


	<b>HEALTH AND SAFETY POLICY</b>	
	<p><b>Summary</b></p> <p>This is an overarching policy that is applicable to and will support The Bridge School staff members to meet their legal health and safety obligations, as well as its learners, visitors and other users of the premises. It applies to the main school premises at Rear of 2A Bensham Manor Road, CR7 7AA. The Bridge SEN School will review its health and safety systems and procedures at least annually to ensure that they reflect legal responsibilities associated with applicable HSE laws, regulations, approvals, licences and other legal requirements, as per:

- International, national and regional standards
- Industry codes and best practice
- Contractual requirements
- Expectations of regulators and other key stakeholders

Systems and procedures will be made available to those working for and on behalf of The Bridge SEN School so that they are aware of their individual health and safety obligations.

A health and safety management structure is implemented to support the delivery of health and safety policies, systems, objectives and targets, to review health and safety performance and respond to health and safety incidents.

The Bridge SEN School is charged with implementing this policy by use of a suitable safety management system. **Edith Eneanya-Bonito**, the Principal and Director, seeks and expects full co-operation and support of entire The Bridge SEN

School team to ensure that the Health and Safety Policy and the arrangements that are put in place to support the objectives of the policy are implemented effectively. The School Principal/Director will have day-to-day responsibility for ensuring compliance with this policy.

The Health and Safety Policy '**Statement of Intent**' at The Bridge SEN School will be ratified and signed, which signifies the commitment of The Bridge SEN School to ensuring that the successful management of health and safety is of paramount importance within The Bridge SEN School. A copy of the Health and Safety Policy 'Statement of Intent' is displayed in a prominent location at The Bridge SEN School and will be reviewed at least annually.

### **Health and Safety Roles and Responsibilities in The Bridge SEN School**

#### **The Executive:**

The Principal has ultimate control of the school. She will:

- Decide policy and ensure its effectiveness on a regular basis.
- Give strategic guidance.
- Monitor and review health and safety issues.
- Ensure adequate resources for health and safety are available.
- Take steps to ensure the school site, equipment and systems of work are safe.
- Ensure that the school provides adequate training, information, instruction, induction and supervision to enable everyone in the school to be safe.
- Maintain the premises in a condition that is safe and without significant risk.
- Provide a working environment that is safe and healthy.
- Provide adequate welfare facilities for staff & learners.
- In their critical friend role, maintain an interest in all the health and safety matters.
- Review and monitor the effectiveness of this policy.

#### **The Head Teacher / Deputy Principal is responsible for the day to day running of the school. They will:**

- Promote a positive, open health and safety culture in school
- Report to Director and Governors on key health and safety issues
- Seek advice from other organisations or professionals, such as the Health and Safety Executive, safety advisers etc. as and when necessary
- Ensure that all staff co-operate with the policy
- Devise and implement safety procedures
- Ensure that risk assessments are reviewed on an annual basis

They will:</b></p> <ul style="list-style-type: none"> <li>• Ensure risk assessments are accurate, suitable and reviewed annually</li> <li>• Deal with any hazardous practices, equipment or building issues and report to the Head Teacher / Deputy Principal if they remain unresolved</li> <li>• Provide a good example, guidance and support to staff on health and safety issues</li> <li>• Carry out a health and safety induction for all staff and keep records of that induction</li> <li>• Keep up to date with new developments in Health and Safety issues for schools</li> <li>• Carry out investigations into accidents and produce reports / statements for any civil or criminal action which may arise</li> <li>• Ensure any contractors on site are competent in health and safety matters</li> </ul> <p><b>The Welfare Officer is responsible for day-to-day maintenance and other issues. They will:</b></p> <ul style="list-style-type: none"> <li>• Ensure that any work that has health and safety implications is prioritised</li> <li>• Report any concerns regarding unresolved hazards in school to the senior management team immediately</li> <li>• Ensure that all work is undertaken in a safe manner</li> <li>• Carry out quarterly checks of the premises to spot any disrepair or potential hazards</li> <li>• Ensure that all cleaning staff are aware of safe working practices, especially regarding reporting of hazards, the use of hazardous substances and manual handling</li> <li>• Carry out a weekly test of the fire alarm</li> <li>• Ensure all contractors are 'inducted' and shown the relevant risk assessments, asbestos records and are made aware of any fragile roofs or other hazards in the areas where they will be working</li> <li>• Fully co-operate with health and safety arrangements during larger building projects</li> </ul> <p><b>All School Staff will:</b></p> <ul style="list-style-type: none"> <li>• Read the Health and Safety Policy and sign it</li> <li>• Comply with the School's health and safety arrangements</li> <li>• Take reasonable care of their own and other people's health and safety</li> <li>• Leave the classroom / playground / office in a reasonably tidy and safe condition</li> </ul>

	<p><b>Procedure and arrangements</b></p> <p><b>1. Risk and Hazard Management</b></p> <ul style="list-style-type: none"> <li>• Risk assessments will be carried out to evaluate and adequately control hazards, to ensure the health, safety and welfare of staff and others who may be affected by the work activities of The Bridge SEN School</li> <li>• Risk assessments will be recorded in appropriate documents in accordance with the Risk Assessment Policy and Procedure at The Bridge SEN School</li> <li>• Arrangements will be made for putting into practice the preventative and protective measures that follow on from the risk assessment</li> <li>• Risk assessments will be regularly monitored and reviewed to ensure they remain suitable and sufficient. They are updated in accordance with legislative and contractual requirements, standards and codes of practice</li> <li>• The outcomes of risk assessments will be readily available and communicated to staff. Staff receive instructions and training associated with the level of risk identified and the control measures taken to prevent or control risks</li> <li>• Contractors and employees are involved in the development of risk assessments and The Bridge SEN School will seek their feedback and act on any concerns</li> <li>• Risk assessments in relation to Contractors will be kept under their possession and staff informed of this arrangement</li> </ul> <p><b>2. Accidents and Incident Reporting</b></p> <p>The accident reporting folder can be found at reception.</p> <ul style="list-style-type: none"> <li>• In the event of an accident/incident, staff will ensure that a detailed entry of the event is recorded on an accident form and will notify their line manager who will subsequently determine, in conjunction with the Health and Safety Committee at The Bridge SEN School, where appropriate, if notification is required under <u>The Reporting of Injuries, Diseases and Dangerous Occurrences Regulations (RIDDOR) 2013</u></li> <li>• Where an accident/incident has occurred, it is necessary to carry out a review of the risk assessment of the task being undertaken at the time, to ascertain if additional precautions, an alteration to the method of work or additional control measures are necessary. This must be written down and the conclusions clearly defined and acted upon</li> </ul>

	<ul style="list-style-type: none"> <li>• The Bridge SEN School will use the information to prevent re-occurrences where reasonably practicable</li> <li>• If an accident, incident or near miss involves a contract or Contractor, London Borough of Croydon's Safeguarding Team will be informed. The Bridge SEN School will be aware of their requirements in relation to the Duty of Candour.</li> </ul> <p><b>Administration of Medicines</b> (See the school's medical policy for further information)</p> <ul style="list-style-type: none"> <li>• Medication is only administered to learners when the parental consent form has been completed.</li> <li>• The medicine will be administered by one nominated member of staff for each pupil and appropriate records kept and signed by two members of staff.</li> <li>• Medicines are only administered during school time when they have been prescribed by a child's GP or other relevant medical professional</li> <li>• The only exceptions to this are asthma medication and 'epipens' (following discussion with parents) which may be kept in appropriate locations, out of the reach of other learners, as appropriate</li> <li>• The doses administered during the school day are to be kept to the minimum, e. g. a course of antibiotics requiring four doses a day - only one dose (lunchtime) will normally need to be administered at school</li> <li>• The school medical rooms are located on the ground floor in the North Western section of the school next to Mercury Classroom and on the first floor next to the storage room and opposite Jupiter classroom.</li> </ul> <p><b>Cleaning</b></p> <p>The Bridge SEN School recognises the importance of maintaining clean and hygienic premises. The following health &amp; safety arrangements are in place:</p> <ul style="list-style-type: none"> <li>• A cleaning rota has been established for all areas of the school.</li> <li>• Suitably competent staff have been employed to clean the premises on a regular basis.</li> <li>• Cleaning staff are provided with suitable protective clothing (e.g. plastic gloves and aprons).</li> <li>• Cleaning staff are provided with suitable hand washing facilities.</li> <li>• All cleaning products are kept in cupboards out of reach of learners.</li> <li>• All premises are to be cleaned and tidied before learners arrive.</li> <li>• Hygienic and safe cleaning materials are available for use in emergencies.</li> <li>• Toilets are regularly checked for cleanliness.</li> </ul>

	<ul style="list-style-type: none"> <li>• Surfaces and tables are wiped clean between activities during the school day and the additional uses of the premises used after hours or on the weekend.</li> <li>• Cushions and blankets are regularly washed.</li> <li>• Regular pest control visits are conducted by a competent specialist pest control contractor for preventative control.</li> <li>• The school office holds COSHH records of all products used by cleaning staff and the pest control contractor in case of emergencies.</li> <li>• Good health and hygiene practices are actively promoted through notices, signs, posters, leaflets and staff meetings.</li> </ul> <p><b>Control of Hazardous Substances</b></p> <ul style="list-style-type: none"> <li>• The use of hazardous substances in school will be kept to a minimum</li> <li>• They will complete a COSHH assessment for all hazardous substances used on site</li> <li>• The associated procedures and control measures will be funded and enforced</li> </ul> <p><b>Educational Visits</b></p> <ul style="list-style-type: none"> <li>• The Educational Visits co-ordinators are the SENCO and Head Teacher / Deputy Principal.</li> <li>• All off site trips will be subject to risk assessment.</li> <li>• Guidelines for Education Visits are kept in the school office.</li> </ul> <p><b>Electrical Testing</b></p> <ul style="list-style-type: none"> <li>• All items of portable electrical equipment in school are inspected and checked annually</li> <li>• Records of these checks are kept in the school office</li> </ul> <p><b>Employee Health and Wellbeing</b></p> <ul style="list-style-type: none"> <li>• The school Staff handbook outlines in the school's Sickness/Absence Policy</li> </ul> <p><b>Fire Safety &amp; Evacuation of the Building</b></p> <ul style="list-style-type: none"> <li>• Fire exits have appropriate signage</li> <li>• Plans showing exit routes are displayed by the door of each classroom</li> <li>• A fire drill is practised and documented once a term by the Site Manager</li> </ul>

#### STATEMENT OF INTENT


